Call to order

> Presentation

O Mayor Kalaj opened the pubic hearing regarding the creation of a Village Department of Transportation. He asked engineer Fusco to introduce the matter. Engineer Fusco stated that the Village Board wisely has determined that they felt it would be appropriate to form a Department of Transportation Commission. Based on all the ideas that have been floating and the vision of the Village of South Blooming Grove Village Board towards widening Route 208, putting up a temporary traffic light and things of that nature, it is obvious that the Village Board could use the help of a commission. Towards that end, this is a Local Law of 2022 for the formation of a Department of Transportation Commission. Mr. Fusco read the proposed local law 6 of 2022.

Public Comment

Bonnie Rum – inquired about the terms of the members of the commission, she was confused. Al Fusco advised that there will be 5 commissions appointed for 1,2,3,4 and 5 years. As one term expires, in a year, you could then be appointed again for 5 years and so on and so forth. Joel Stern explained further that it is going to be staggard appointments. Ms. Rum added that staggard appointments are a good idea, but she did not find the explanation any clearer. It would be nice if Scott Ugell could explain it but she doesn't know if...Mr. Ugell can you explain the terms? Mr. Ugell advised that it was just explained. Ms. Rum advised that it is not clear. Al Fusco clarified stating that one person is appointed for one year, one person for two years, one for three years and one for four years and one for five years. After one year a term has expired and he/she could be

- reappointed for five years and that way everybody would continue by one year. **Ms. Rum** I got it, thank you very much.
- O Sue Anne Vogelsberg inquired with both of the commissions are these people going to be paid employees of the Village because you didn't have that budgeted. Joel Stern advised no. Sue Anne asked they are volunteers? Joel Stern advised volunteers. Sue Anne they are volunteers, so then how is that if they are just volunteering what if they make a wrong decision are they going to be held accountable, just as trustees can be sued, if they are volunteers are they going to be held, how is that going to work. Attorney Ugell when you serve on a board, our village code indemnifies people personally, if they are appointed they will be indemnified. Sue Anne stated so they are volunteering, there is no salary involved and no expense to the village then for these ten people. Thank you.
