Mayor's Comments

The Mayor asked Aide Ekstein to brief the board on his meeting with the Fire Chief today. Mr. Ekstein stated that there were conversations with the village board in the past regarding fire response and fire prevention. He is happy to say they have a very good relationship with the Chief and we had a walk through with the school building and we are looking forward to a great relationship. There was a lot of talk about members of the community who would like to join the fire department in the past and were not successful for various reasons so in order to open up a pool of people to join a fire department in the local community we discussed in the past potentially forming a fire department. Again it is no discounting anything from the existing fire department, we are changing the district of the current fire department, the independent fire department is staying the same as it is now, we are just from a village perspective, opening it up to assist the fire department with more personnel, for first responders, for exterior fires, for traffic control if they need help from us. Again, this is for people to go to the proper training they would need. It is here to help the community, help the village prevent and be more proactive for all the live and work right here to be able to put out fires. **Chief Castellano** commented that they never received any applications from people wanting to join the department, everyone is entitled to join. **Mayor** is concerned about having two fire

companies and he understands that in the past there was a gentleman in the fire department, **Mr. Ekstein** explained further that two of the members applied unfortunately as you said it wasn't even received. Right now we are discussing having people who live and work in the village to be part of the fire department.

Public Comment

- Sue Anne Vogelsberg At the May 8th meeting there was a resolution that fortunately wasn't voted on to have A1SN Marketing to provide PR marketing for the village. I cannot find any evidence of that company anywhere. I looked all over the internet and I can't find this company. So thank goodness you didn't vote on it because it concerns me. Mr. Ugell was supposed to look over the contract. You guys didn't vote on it. If you did then we have bigger problem because there's no company. Are there any updates on that. The website is already there and people can log into it. But we have a vast population that doesn't have access to the internet. That goes to another point I have when I was a Trustee I went for NYCOM training. I didn't know how to be a Trustee and I'm sure you guys didn't know how to be a trustee either and one of the things I was told was take people's comments, say thank you very much and I will get back to you. There is not supposed to be this give and take. So when I ask questions here I expect that you guys are going to do your research and you are going to come back with an answer. Either give me a phone call, send me an email or bring it back to the next meeting. Joel read a letter in December of 2022 about the Mangin Road extension. I foiled it and haven't received. Joel said he submitted it to the county. The county has no record of that letter. I'm just reminding you about this that's something that we need to visit because that road is already in place. At the May 18th Planning Board Meeting Village Planner Shepstone spoke about a very active recreation department. I know nothing about it. There's nothing on the website so there could be updates posted about that. 1
- Sue Anne Vogelsberg 159 Prospect I'm going to keep bringing it up it was there cut on March 17 and the brush remains 2 months afterwards and it's posing a fire risk for those of us that live over there. Any updates on that garbage contract? Because I haven't received any bills or any kind of notification on it and to comment on the resolutions 2 fire departments in a village. I agree with you Mr. Mayor. It's not a good idea.
- Bonnie Rum I do agree with you we can't have 2 fire deparments. I assumed that Simon Schwartz received training for the Planning Board. If he didn't get official training, he cannot be reappointed. The other boards are required to get training and if they don't do it within the first year they cannot be reappointed until certainly they get training. So I'm guessing that you have that.
- Bonnie Rum My question about fair housing resolution what is that and what is the definition of the fair housing. Al Fusco the concept of community development. It's the requirement that the board acknowledges that this is the community that has equal opportunity employment and fair housing. One of the things that they made us do is both Kerry, Karen and myself sat in for a 2 ½ hour presentation by a Community Development Department in relationship to watching for unfair housing standards in the community and for us to enforce that. It's to instruct the Board and the participants and consultants as to what their commitments are and there will be a resolution of the Board supporting their house and their opportunities. Things of that nature. In order to participate

you need a federal grant. **Bonnie Rum** – So that's something you vote on but how do you implement it. **Al Fusco** – I think we already do it on a regular basis

- Scott Morrice asked an audience member who said he tried to join the fire department how did you do it? He was asking who he gave it to and when. Audience member replied William or Bill in 2017. He said he will look into it because he never stopped anyone from coming down. Isaac Ekstein In November 2020 we went to the meeting in the fire district and pointed out at that time, that people were submitting applications and were not receiving a response. He advised that Scott should remember the response they received. Scott Morrice I've been there for 28 years and I'm pretty sure either they came down with the application with the check and then they have to go and get their medical they are allowed to join. There's no stopping them. There's plenty of things to do and you have 2 years to become an internal firefighter and after that no longer.
- Uri Deutch On December 6, 2017, I hand delivered a fully filled out application to join the fire department. I am actually a NYS certified EMT. I had my training from the O.C.E.M.S. I served as an EMT in the Monroe Ambulance for a few years. As I moved here, I was ready to serve the community. I've risked my life to pull people out of burning cars. I have not been afforded the denial letter or a rejection letter. I've just reviewed the application online for the South Blooming Grove Fire Department both the actual application and the application instruction. There is no mention of any need for a check and if I'm mistaken, I would be glad if anyone can show me where it is. The fire department here has been telling that to the County and even if we can become a county firefighters, they should be realistic and see there is a large community here that needs to be.... I don't know if you guys know but the South Blooming Grove Fire Department and Department of Health met with first response agency. The nearest ambulance agency is fifteen minutes away. If someone is in cardiac arrest, they need to respond, if they don't have enough members, they cannot be picky and say oh we cannot take you because you have a beard, you don't qualify for everything, they need to be realistic and they have a community to protect, and they have to look at that without any prejudice and if that's not the case then I don't think two fire departments is a good idea either. But either they shape up or I don't know, you tell me.
- Shia Liberman I have been a member of the KJ EMS for over 10 years, I have worked hand in hand with the Blooming Grove Fire Department. I have only good things to say. When I first started he had similar issues such as don't come into my district, etc. He feels at this point a majority of us are grateful to have extra and full coverage. I applied as well, he doesn't resent but feels we are going backwards. If we could work something out it would be helpful. We are people that help others and should work together.

Mr. Ekstein advised that he met with the Police Chief a few weeks ago. There is the school up on Fort Worth we increased the police presence like when the buses are coming and going to make sure they are obeying all the traffic and stop signs. I think it's a big success so far.

Mayor asked again that residents only flush toilet paper to help alleviate sewer back ups. Safety vests are very helpful at night.

Chief Castellano wanted all to be aware of lithium ion batteries. They are very dangerous if they are not charged properly or damaged. So I know all the kids have the scooters and hover boards and e-bikes. I just want the adults to know that you should use the proper charger. If they are damaged or anything do not charge them because they are very dangerous.

Mayor Kalaj – I don't think it's wise to have two fire departments in the village.
