Mayor LoFranco advised about an upcoming road closure of Route 208. Starting on October 16, there will be a soft closing through October 20. Public Comments

- o John Hickey, Merriewold Lane South Speeding is an issue on Merriewold Lane South. Mentioned the deer are in their rut and that motorists should be aware of higher risk of traffic accidents.
- William Finney, 3 Merriewold Lane South Mentioned excessive speeding issue on Merriewold Lane South. Mayor LoFranco advised that he is meeting with Blooming Grove Police Tuesday. Mr. Finney reported numerous houses on Merriewold Lane South with high grass. Note was taken of locations.
 - Mr. Finney inquired about the home at the corner of Virginia and Merriewold Lane South, Mayor LoFranco offered that the building permit is currently still open.
 - Asked about driveway gates at the property located on Merriewold Lane South. A permit for a driveway has not been issued or applied for at this time.
- John Salka, Clove Road Expressed concern about nonpayment of water and sewer bills, asked for review of process when bills are unpaid. Asked if higher fines or disconnecting of water service may be considered.
 - Mr. Salka inquired if use of construction fence is currently part of the zoning code. He proposed that the Village consider adopting a law requiring construction fence be installed for large projects. Attorney McKay offered that this is in state code and can be enforced by the building inspector.

- Donna Douglas, Lake Shore Drive Expressed gratitude for the efforts placed forth regarding the cleanup of properties that require lawn maintenance. Mentioned car for sale parked in a precarious position on Route 208 by Metro Sound Pros. Village to follow up on zoning code.
