> <u>Correspondence</u>

- Village Accountant Marvin Nyman presented the proposed budget to the board and the public. Contractual expenses with the town have incurred small increase in budget. An additional part time building inspector has been added to the town. Capital projects fund accounts for the majority of the budget increase to allocate for highway projects that will need to be addressed. Discussion ensued regarding the cell tower property that is currently rented through the village. BAN will be needed for capital expenses for water and sewer projects that are to be completed in 2018.
