#### > Mayor Comments

- Mayor LoFranco addressed various water issues that occurred in the previous week. On Wednesday, February 7 and 8, there was an obstruction in the Orange and Rockland well that needed attention. On Friday, February 9, after receipt of several brown water call, a water main break was discovered on Strawberry and effected the water to homes in the surrounding area. A sewer main backup took place on Virginia the same night. Advised residents to be mindful as to what is put into the sewer systems; that no more than toilet paper should be flushed. Flushing the sewers on a regular basis is inconvenient and will be very costly to residents.
- Mayor addressed the issue of dumpsters that are on front lawns; advised that one was removed and the other has been issued a violation. The violation gave five days for compliance; the property owner has been issued a court appearance for non-removal of the dumpster.
- Mayor LoFranco gave an update on parked cars on Dallas Drive; the police department has been notified and will monitor the area.

- Brian Mullan, inquired about the length of time temporary signs can stay up. Mayor LoFranco advised that the village is working on proposed local law regarding temporary signs and a public hearing is to be set.

   Attorney McKay explained the process requires review by the County of Orange as well as the Planning Board. Timelines and the process to file a local law was discussed at length.
- Ingrid Pappas, Asked why a new law needs to be created regarding temporary signs; attorney
  McKay advised that all signage, e.g. realty signs, will be addressed under the new law. Currently
  there is no permit required to install temporary signs, there will now be a timeframe as to when
  signs need to be removed.
- Steve Kearins, Resident asked about the upcoming elections, how would residents know who is running. Clerk advised the information will be posted in the Time Herald Record within the next few days.
- O Debbie Bragado, Asked Attorney McKay for an explanation about the correspondence from Orange County regarding HUD. Mr. McKay advised that he is in contact with the County of Orange for clarification of the details and will report at the next meeting.
- Wanda Rudzinski, Resident mentioned that Sears Road is mess and asked what is needed to request a new road. Mayor will look into what can be done when the weather warms and will consult with the Village engineers.
