➤ **Public Comments**

- Erin McEvoy – stated that her road (Sears Road) was a disaster in the recent storms. She advised that it appears that as you go higher into the Village Roads, they are in worse condition. i.e. When driving up Duell is okay and then when you make a left onto Dallas Drive it is worse and becomes worse as you drive up during snow/ice event. Deputy Mayor Hickey advised that he will discuss this with highway maintenance. Ms. McEvoy also advised that after helping her new neighbors during the snow storm they reciprocated and the relationship is improving in a positive manner.
