crack in the road at 27 Duellk; deputy mayor informed that the asphalt companies are not open yet for road repair, as soon as weather permits, issues will be addressed.

- Brian Mullan, – Requested a listing regarding what is acceptable for garbage pickup. Mentioned that electronics are not allowed. Village clerk advised the garbage company sends a letter to residents. Additional information is available on the Town of Blooming Grove website. Enquired about locations that have been listed on google maps as businesses in residential zoned areas. Deputy mayor Ross advised that the issue will be investigated.
- Bill Finney, – Resident enquired about speeding on Merriewold Lane South, mentioned that the Blooming Grove Police Department was out to the location and wrote numerous tickets. Advised that the speeding has continued, is requesting the police return to address the speeding issue. The board advised that residents need to contact the Blooming Grove Police Department and to observe speed limits.
- Patti Morrice, – Inquired about an update on temporary signs, Deputy Mayor Ross advised that the law is in the stages of being passed.
- Doug Cairns, - inquired about potential additional traffic lights on Route 208. The board advised that Route 208 is a state road and any changes are subject to New York Department of Transportation. The board advised that the speed limit was recently reduced to 45 mph on Route 208 from Route 17 to Round Hill Road.
- Donna McGoldrick, – inquired about County Waste containers that have not been removed. The board will contact the town to have the containers removed.
- Shirley Mendy, – Mentioned garbage and TV left out at 3 San Marcos. Incident report will be sent to building department.
- John Salka, – Resident enquired about proposed local law regarding temporary signs, the village board advised the board is waiting for response from the county and planning board. Resident enquired about Lake Ann property, mentioned that there are buildings that are visible from the road that are dilapidated and are dangerous. Violations have been issued. Resident asked about election rules, what are residency rules? The board of elections can answer to all questions on residency law. The village clerk also advised the NYCOM has information regarding election laws in New York State.
- Debbie Bragado, – Inquired about the safety of the propane tanks that are located on the Lake Anne property. The board advised that the property is privately owned and the tanks have been investigated.
