Public Comments

- Erin McEvoy Resident asked what is being done regarding 19 Sears Road; The Mayor advised that the property violation is in the process of being served. Because the property is a rental the owner needs to be located in order to be served.
- Vicki Codner Resident asked the Mayor for update on the speeding solutions on Merriewold Lane South. Mayor Jeroloman advised that he met with the engineer and has downloaded software that will provide information on vehicles speed. Deputy Mayor Hickey described narrowing the roadway with installation of islands in the center of the road appears to the best proposed solution; the theory being that narrowing the roadway will help diminish speeding. The Village engineer is in the process of preparing proposed plans.
- o Residents asked if the same could be applied to various roads throughout the village.
- Ms. Codner advised that reflectors on Merriewold Lane South Islands need replacement. Mayor mentioned replacement signs, reflectors as well as poles have been ordered and will be installed when possible.

Ms. Codner reported that Quality Bus ran a stop sign at Fort Worth, turning onto to Dallas without slowing to oncoming traffic.

Ms. Codner feels that a Dangerous situation exists on Pine Hill Road, multiple cars parked at Pine Hill and Dallas corner blocking the line of sight. Mayor recommended that resident call the police if she feels parking is a safety issue.

- Evan Sick– Resident states the buses are speeding on his street on a daily basis. The speeding occurs on a daily basis. Mayor suggested the resident call the police and if possible to get the bus company and number; the police are aware of the situation and issuing summonses as needed.
- Marlene Sick, Resident stated she needed to call the police regarding cab services using their horns in excess at 19 Pine Hill Road. Resident called Royal Cab Company at 9:00 pm regarding the disturbing noise; employee was not responsive to complaint. Ms. Sick mentioned same home has a refrigerator sitting outside.
