I would like to commend you for taking the proactive steps to assist with the formation of the UJC Emergency Response Division, your actions have proven to be proactive insightful and visionary!

This Saturday, May 7<sup>th</sup>, I unfortunately had a working electrical fire on my porch, which quickly could have evolved into a full structure fire, but thankfully the UJC Emergency Response Units arrived on scene in less than 2 minutes, and quickly prevented a small electrical fire from becoming a full structure fire and loss of structure, while safely evacuating my wife and kids from the burning house.

While I have all of the respect and kind words for the SBG fire department and the neighboring fire departments, who have also arrived and assisted with the afford, it took them 13 additional minutes from when I called 911 to arrive on scene.

I am horrified by the mere thought of what would have taken place have not the UJC Emergency Response Units arrived in the nick of time so quickly and efficiently and took control of the situation.

I am thankful and appreciative for your leadership and creativity and always thinking out of the box when it comes to the safety and wellbeing of our community even when sometimes it might not be so politicly correct.
