 The public notice is regarding an application for a zone change at 1032 Route 208 which is currently zoned as RR to change to RC1 within the Village of South Blooming Grove.

#### **Public Comments**

- Brian Mullan, 33 Duelk Avenue Are they required to submit plans once the zone is changed?
   Attorney Lynch advised that the village must accept all applications.
- Sue Blakeney, 481 Clove Road Inquired what the new zoning to RC-1 would permit. Mr. Lynch
  explained that the zoning change had been proposed to the prior owner and that the new owner is not
  required to give details on what use the owner may file an application for.
- o John Daley, Clove Road when did this property become zoned as RR. Mr. Lynch offered that he did not have the dates when the adjacent properties changed zoning code to RC-1, but that 1032 Rte. 208 was the only property that did not change zoning at the time.
- Bonnie Rum, Lake Shore Drive stated that the person who purchased the property knew at that time what the property was zoned for. Asked about rumors that the property would be developed as a bus parking garage. Mr. Lynch explained all applications need to go before the Planning Board for approval.
