**RESOLUTION REGARDING CONTINUATION OF PUBLIC HEARING ON THE
CLOVEWOOD PROJECT
AMENDED AS WELL AS SUPPLEMENTED DEIS**

WHEREAS, the Village of South Blooming Grove, New York (“Village”) from time to time considers certain land use Projects in the Village, including a Project submitted and known as the “Clovewood Project” (“Project”); and

WHEREAS, within the Village concerning this matter, the Board of Trustees (“Trustees”) and the Village Planning Board (“Planning Board”) from time to time will undertake review of Projects and with the Clovewood Project the Trustees along with the Planning Board are both Co-Lead Agencies under SEQRA in reviewing this Project; and

WHEREAS, the Clovewood Project prepared an amended and supplemented Draft Environmental Impact Statement (“DEIS”) that was accepted as complete by the Co-Lead Agencies and the subject of a Public Hearing on August 10, 2020 which was adjourned without date before approximately ten persons wishing to speak could be heard; and

WHEREAS, the Co-Lead Agencies have determined to continue said Public Hearing on said DEIS; and

WHEREAS, the Co-Lead Agencies recognize that there existed certain guidance by New York State and other Health Officials about the existence of and spread of the COVID-19 Virus and understood that appropriate precautions need to be in place to conduct said Public Hearing.

NOW THEREFORE, it is Resolved by the Trustees as follows:

Section 1. All “**WHEREAS**” paragraphs are incorporated herein by reference as though set forth in full herein.

Section 2. The Trustees hereby determine to continue the adjourned Public Hearing on the Clovewood Project DEIS and requests the Planning Board to confirm December 28, 2020, 7:01PM as a mutually agreeable date for said Public Hearing and that any written comments be received by and in the Office of the Village Clerk concerning the amended and supplemented DEIS no later than 3:00PM three (3) days before the Public Hearing recommences and also be permitted within a ten (10) day time period after the close of the Public Hearing to provide any additional comments all of which will be permitted if so received by the Village Clerk no later than 3:00PM on that tenth date.

Section 3. The Public Hearing for December 28, 2020, will be a ZOOM meeting. Members of the public wishing to make an oral presentation via ZOOM are advised to contact the Village Clerk, Kerry Dougherty on or before 3:00 PM, December 23, 2020, to register to speak at the Public Meeting set for December 28, 2020. Written comments are encouraged to be submitted and will also be received by the Planning Board and Village Board up until 3:00 pm on January 7, 2021, if submitted to the Village Clerk at Village

Hall, 811 Route 208, Monroe, NY 10950 or by email to clerk@villageofsouthbloominggrove.com .

Section 4. The Village Clerk shall cause appropriate public notice of the foregoing December 28, 2020, Hearing Date as well as the method of scheduling of the speakers and registering with the Village their request to speak before the said Public Hearing Meeting after consultation with the Planning Board Chairperson as required by applicable law. Should said dates need to be changed, the Trustees authorize the Clerk in consultation with Special Counsel to change the dates of the Public Hearing and the time for submission of written comments after the Public Hearing.

Section 5. This Resolution shall take effect immediately.
