RESOLVED, by the Village Board of the Village of South Blooming Grove, that pursuant to New York State Election Law Section 15-116(1), the Village Board has determined that it is necessary to employ the clerical and custodial services of two individuals to assist the Election Inspectors in the performance of their duties during the Village's General Election and that Norman Dunne and/or Danny O'Keefe, shall provide such clerical and custodial services; and be it further,
