BLOCK GRANT PROGRAM APPLICATION FOR THE FISCAL YEAR 2022**

**WHEREAS**, a resolution was duly adopted by the Village Board of the Village of South Blooming Grove on June 14, 2021, scheduling a public hearing to be held by said Governing Body on June 25, 2021, at 11:00 am via Zoom Webinar #96263377246 to hear all interested persons on a proposed Orange County Community Block Grant (“CDBG”) for Fiscal Year 2022, which program provides annual grants on a formula basis to Entitlement Communities to support viable communities by providing decent housing, suitable living environments and expanded economic opportunities to benefit people with low to moderate incomes; and

**WHEREAS**, notice of said public hearing was duly advertised in the Times Herald-Record, the official newspaper of said Village; and

**WHEREAS**, said public hearing was held on June 25, 2021, via Webinar and all parties were permitted an opportunity to provide comment concerning potential projects to be funded; and

**WHEREAS**, the Village Board wishes to submit its Municipal Grant Eligibility Form for consideration under the Orange County Community Development Block Grant (CBDG) for 2022; and

**WHEREAS**, the Village Board has read and understands the Municipal Grant Eligibility Form, has met all of its applicable requirements and that the information contained in the form is accurate and true to the best of their knowledge; and

**WHEREAS**, the Village Board, after due deliberation, finds it in the best interest of said Village to apply for the Fiscal Year 2022 Municipal Grant Program;

**NOW, THEREFORE, BE IT HEREBY RESOLVED:** that the Mayor and the Village Engineer are hereby authorized to submit an application for funding to the CBDG.
