- 4. Provide a boundary and topography survey signed a sealed by a New York State Licensed Land Surveyor.
- 5. A drainage report should be provided.
- 6. A 30 foot wide road dedication measured from the white line on New York State Route 208 should be included on the plan.
- 7. Typical details should be provided in the plan set, including but not limited to sidewalk, parking area pavement, curbing, dumpster enclosure, handicap accessibility, and handicap parking.



- 8. Building to include sprinkler, show connections to the municipal main with a minimum of a 4-inch ductile iron pipe.
- 9. This project may require referral to Orange County Planning for 239 GML due to the projects proximity to New York State Route 208.
