



AS-BUILT SITE PLAN SCALE: 1"=30'





SECTION 110-58: NO SHRUBBERY, HEDGE OR OTHER NATURAL GROWTH, OR FENCE (EXCEPT A TRANSPARENT FENCE SUCH AS CHICKEN WIRE, IN WHICH THE SOLID AREA IS NOT MORE THAN 5% OF THE TOTAL AREA OF THE FENCE) OR WALL OVER THREE FEET HIGHER THAN THE APEX AT THE CENTER LINE OR THE STREET SHALL BE LOCATED WITHIN THE TRIANGULAR AREA SHOWN ON THIS PLAN AT THE INTERSECTION OF MANGIN ROAD AND NYS ROUTE 208.
